This License is issued subject to the "General Conditions" for Ordinance #420 type sales conducted in the Borough of Parkesburg.

**GENERAL CONDITIONS FOR SALES TO BE HELD
PURSUANT TO BOROUGH OF PARKESBURG ORDINANCE #420**

- ▶ **No person may hold a garage sale, lawn sale, yard sale, or home sale without first obtaining a license from the Borough.**
- ▶ **All licenses must be obtained not less than fourteen (14) calendar days before the first day of any sale.**
- ▶ **No more than three (3) licenses may be issued by the Borough per calendar year per residence.**
- ▶ **All goods to be sold at any sale for which a license is required must belong solely to the household where the sale is held. (See SIX "Limitation on licenses and goods to be sold" of Borough Ordinance #420).**
- ▶ **All sales may be held only between 8:00 a.m. and 8:00 p.m. prevailing time on any day**
- ▶ **No sale shall be conducted within or upon any public right-of-way, including but not limited to a sidewalk, street, alley, etc. or any part thereof.**
- ▶ **The license, when issued by the Borough, must be displayed at all times during the days of any sale.**
- ▶ **Copies of Borough Ordinance #420 are available for inspection at the Parkesburg Borough Hall.**
- ▶ **Signs for any sale may be posted on sale premises *only*.**
